# **Aims**

This policy statement sets out the school's arrangements for managing the access of providers to students at the school for the purpose of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997.

#### Student entitlement

Students in years 8-13 are entitled to:

- find out about technical education qualifications and apprenticeships opportunities, as part
  of a careers programme which provides information on the full range of education and
  training options available at each transition point
- hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through assemblies, PSHE career sessions, options events, group discussions and taster events
- be supported in and understand how to make applications for the full range of academic and technical courses

### **Premises and facilities**

Providers are welcome to leave a copy of their prospectus or other relevant course literature at Reception, this will be displayed in the careers section of the School Library. This Resource is available to all students at lunch, break time, before and after school.

# **Opportunities for access**

It should be noted that school assemblies are an integral part of the PHSCE programme and a full curriculum is in place across the year for KS4 students, as such regular year group assemblies are not available to providers in these year groups. However, a number of events are integrated into the school careers programme, and will offer providers an opportunity to come into school to speak to students and/or their parents/carers.
